

As Alberta legislation becomes increasingly stringent on individuals or corporations designated as the Prime Contractors, those Prime Contractors realize their due diligence is, in many ways, connected to the performance of their subcontractors. As a direct result, Prime Contractors are asking their subcontractors to provide more and more detailed information on Occupational Health and Safety systems and previous performance. This Occupational Health and Safety information is not only being asked out in the field but even before tendering! This session is designed to look at these issues and understand how this directly affects your occupational health and safety obligations. Topics covered will include:

- How Alberta legislation provides legal obligations and liabilities for contractors;
- Why common sense does not apply, and why clear contract language, by the contractor may be ignored by the courts;
- How the work of the contractor is sometimes the responsibility of the facility owner or prime contractor;

- Pitfalls of working to your occupational health and safety program and that of the owner, prime contractor, etc.;
- How to handle safety issues where a third party is controlling a project; and

##### **STOP THAT HEARING LOSS! NOW!**

*Brad Witt, Sperian Hearing Protection*

Preventing noise-induced hearing loss at the workplace appears deceptively easy -- ‘just wear the hearing protection.’ But hearing loss continues unabated in many industries, and for good reason: when a worker puts in an earplug, we don’t know how much noise is still reaching the eardrum. In most Hearing Conservation Programs, the feedback mechanism for judging the effectiveness of hearing protectors is annual audiometric testing, a feedback loop that takes years to identify a problem case (and only after a hearing loss has already occurred).

8:30 am—10:00 am

This presentation covers the basics of hearing conservation as a review, and progresses to a Train-the-Trainer module on the proper fit of hearing protection. The methods of obtaining CSA attenuation ratings will be described, and the pending introduction of a new two-number range on the NRR label will be discussed, with recommendations on implementing this change in Canadian Hearing Conservation Programs.

The emerging technologies of field verification (fit testing of hearing protectors) and in-ear dosimetry (real time noise dosimetry *under* the hearing protectors) will be presented, including advantages of each system. Data will be presented from companies who have implemented these technologies, showing implementation requirements, and pros and cons of these technologies. The new technologies provide Hearing Conservation Programs the tool that is critical in stopping hearing loss—immediate feedback on the fit of hearing protection, and the noise dose under those hearing protectors.

The plan's drafter may have taken every conceivable possibility into account, but their experience will be limited and therefore, conceivably may not be as broad as necessary. In what ways can we somehow evaluate our plans to see where there may be areas of improvement?

Participants will learn of latest changes to CSA's Respiratory Protection Standards, including important changes to the CSA Z94.4 Standard on Selection, Use & Care Respirators. Emphasis will be placed on providing information about the expansion of the standard to address the selection of respirators to protect against infectious agents / bioaerosols. Hear of the updates to fit testing protocols, assigned protection factors, health surveillance and training requirements and learn about improvements to sections outlining the limitations and capabilities of respirator types and requirements for the cleaning, inspection, maintenance, and storage of respirators. To help guide the user through the respirator selection decision making process, a review of changes to the selection process / flowchart will also take place.

Canadian efforts are underway to formulate a national mental health strategy over the next two years. Occupational mental health is being considered as important and integral to effective national mental health improvement strategies.

Currently, mental health improvement efforts in workplaces have arisen from many varied and different directions, such as legal requirements, contractual obligations, employee welfare concerns, disability insurance provisions and social responsibility efforts. Some of these efforts focus on individual workers or sub-populations of unique groups of workers. Other approaches have tried to provide more uniform services to the entire workforce.

A scan of global research in workplace mental and psychosocial health has shown that workplaces are unique settings and they require different strategies and approaches in contrast to public health based mental health improvement strategies.

A number of ideas and solutions for improving workplace mental health will be presented from international and Canadian experiences.

Workers in a variety of industries throughout several parts of the world are required to perform work in cold environments. Health and safety practitioners are well aware of the need to complete hazard assessments in the work place. In most jurisdictions this requirement is legislated. Hazard assessments typically cover the safety basics: slips, trips, fall, confined space, energy isolation, electrical hazards and others. A hazard often overlooked because it is not well understood is chemical exposure hazards. This course provides the “how to” and learners will have the opportunity to learn “how to” conduct a proper chemical hazard assessment.

Controlling chemical exposure is important to the control of associated health risks and hazards. Worker exposure commonly causes irritation, sensitization, allergy, toxicity and often disease. Occupational illness remains a significant factor in our societies overall health. This course provides a detailed and in depth review of the subject of human toxicology and the health hazards associated with chemical exposure at work.

The core materials covered includes: a basic review of the human physiology and the bio-mechanics of how the body works; routes of entry of chemicals; a discussion on the behavior of chemicals in the workplace and the mechanisms and effects of target organ toxicity and cumulative effects of the most common hazardous materials in use in the workplace.


