**Theme: “Toward Regulatory Harmonisation in Sub-Saharan Africa:
Framework for Consumer Products”**

Background: A strategic and structured framework is needed to harmonise the current regulatory standards guiding product development and regulatory approval in sub-Saharan Africa. Regulatory harmonisation is vital to provide African consumers access to innovative products at affordable costs because different national regulations, processes and standards drive bureaucracy, delays and increase costs to the consumer. In addition, regulatory harmonisation will strengthen and facilitate trade across national borders with resultant significant economic growth in the region.

Goal: Royal Society of Chemistry (RSC) / Procter & Gamble (P&G) in partnership with Non Governmental Organizations (NGOs), relevant regional organizations, and stakeholders from various Ministries of Health in the region initiate the dialogue that will eventually lead to development of a roadmap to attaining a rational, comprehensive, flexible framework for regulatory harmonisation in a way that builds trust, leverages ongoing initiatives, and creates operational efficiencies. It is hoped that the outcome of this symposium is a white paper that includes critical next steps for creating the framework for regulatory harmonisation, identifies owners (leaders), and sets the timing.

Theme: “Hygiene and Health in Sub-Saharan Africa”

Background: Proper nutrition and hygiene have always been cited as key necessities in improving the quality of life in sub-Saharan Africa. Large amounts of effort and funding has been invested in trying to provide the right diet and hygiene care. Recently, more and more emphasis is being placed on hygiene as the critical step in improving the health of children and adults lives in Africa. The newly recognised link between environmental, or tropical enteropathy and nutritional efficiency highlights this importance further. To ensure this problem can be tackled in a sustainable way, key stakeholders from the community and industry must share knowledge and best practice to establish a pathway forward.

Goal: This session will cover the newly recognised link between hygiene and relative effectiveness of nutrition as a critical lever in Africa’s public health arena. Speakers from P&G will discuss the technical impact of products on the elimination of bacteria. They will also discuss the behavior change impacts of Point of Market Entry Programmes on the establishment of good hygiene practices, and explore with the delegates ways to maximize the beneficial impact of these products in sub-Saharan Africa. This session will allow representatives from government, industry and not for profit organisations such as the RSC to collaborate and create a plan to promote community change.
