The conference will examine the extent to which gender should be a factor in the development, regulation and use of medicines and discuss gender considerations in clinical practice.

Objectives of the event

- To increase awareness of the relevance of gender differences when caring for patients and the wider medical and pharmacy professional community
- To enter a dialogue with the pharmaceutical industry and the MHRA/European regulatory authorities on the reporting of analyses by gender in the public domain
- Consider the role of drug development clinical trials and post marketing trials or data collection in identifying clinically relevant gender differences

- Describe ways in which gender may affect drug treatment and patient care
