There will be three specialist workshops, provided by Surveyors, Forensic accountants and Medical experts. Our popular Question Time Session will be chaired by Bernie Rowe of Lyons Davidson founder and former Chairman of MASS.

The conference will be stimulating and challenging, as well as informative, but there will be light relief as well. Jacqueline Storey's talk on 'The Expertise of the Choreographer' will include practical demonstrations of dance from professional dancers, and will provide an insight into a fascinating field of expertise.
